# **Brand Guidelines**



## Logo

#### Logo Type and Mark

"Little Kamper" logo type/mark should be in this horizontal format wherever possible and should be the primary logo used.

#### **Clear Space**

The clear space rule ensures there is enough empty space surrounding the logo mark and logo type to allow for more impact and give enough space between other graphic elements, text, and more.

The mark in "Little Kamper" is used on its side around the area to measure clear space.

#### Dos and Don'ts

Do not rotate or skew the logo in any manner. Do not place the logo on-top colors that are similar in contrast such as 50% gray resulting in low contrast between the logo and the background color. Avoid placing the logo on a busy background or pattern.

The logo may be placed on a light background (10% tint) from the palette. The preferable background color is light mint. A knockout (white) version of the logo may be placed on-top of a black or dark colored background (100% tint) from the palette.


